

# Job Summary

Job Title: Lecturer in Pharmaceutical Science (teaching focused) Grade: 8 Salary: £45,413 to £55,755 per annum, pro-rata if part-time Department: School of Healthcare Hours/Contract: Full-time or job share, Permanent Reference: 11324

#### **Role Purpose**

To draw on academic experience to underpin and carry out activities across a range of areas of academic and university life, aligned with the <u>University's strategic themes</u> of 'Research Inspired Education' and 'Our Citizens,' together with the University values.

The University of Leicester MPharm programme admitted its first student cohort in September 2024. The curriculum has been designed to fully prepare our graduates for the foundation year and expectations to train as an independent pharmacist prescriber.

This is primarily a teaching post, focusing on developing learning relating to pharmaceutics, pharmaceutical chemistry and ideally pharmacology, plus delivering learning relating to physiology, pathophysiology and anatomy required to practice safely as a pharmacist. The postholder will be responsible for developing material relating to these topics as part of Team Based Learning packs; delivering workshops and seminars focusing on the application of these topics to clinical decision-making and question writing; working with the clinical teachers to deliver a fully integrated MPharm programme.

In the University of Leicester MPharm programme the pharmaceutical sciences are taught as part of fully integrated clinically focused modules across all four years, so that students learn the science in the context that they will use it in practice. Teaching will be developed and delivered by staff from both clinical and pharmaceutical science backgrounds, enabling the post holder to support the development of clinical skills and professionalism as well as student's knowledge base.

Whilst embedded in an expanding the MPharm team, the post holder will be expected to largely work autonomously and independently to lead own tasks and meet academic and professional goals.

With 40 weeks of experiential learning embedded within the MPharm program and working in close partnership with both national and local providers, the University of Leicester MPharm is fully focused on the creation of patient-centred pharmacists equipped with the requisite scientific knowledge to enable evidence based professional practice and decision making.

Located within a multi-professional School of Healthcare and alongside a leading School of Medicine, opportunities for multi-professional working and learning for both staff and students are exceptional.

Main Duties and Responsibilities





#### **Research Inspired Education**

- Undertake research-led teaching relating to the pharmaceutical sciences: specifically pharmaceutics, pharmaceutical chemistry and pharmacology and contribute to the wider teaching of anatomy, physiology and pathophysiology as part of the wider MPharm teaching team.
- Develop new learning materials and revise existing learning as the MPharm programme evolves including the development of lab classes and coursework and supervising fourth year masters level projects.
- Support the development of teaching links with the Schools of Biological Science and Chemistry
- Contribute to the development and achievement of the academic strategy in the school and beyond, contributing to teaching policy and providing teaching leadership
- Provide timely formative student feedback and assessment for coursework and examinations
- Contribute to the development, revision and updating of new and innovative programmes at undergraduate, specifically the MPharm curriculum, ensuring they are inclusive, embeds key skills and incorporate sustainable development goals
- Play an active role in the shaping and provision of a comprehensive range of support initiatives at School/College/University level including placement support, links with industry, personal tutor support, employability and outreach activities and open days, ensuring School admissions processes are effective
- Work with students to provide world class teaching and learning opportunities and an excellent student experience, regularly collecting and responding to student feedback
- Develop a profile of pedagogical research, or disciplinary research that enables high quality teaching delivery
- Contribute to projects or scholarly discourse aimed at enhancing pedagogy and student outcomes
